How could this happen? Simple: they didn't have an A1 certificate.

Authorities are now enforcing the issuance of A1 certificates. We've seen a marked increase in spot-checks, border inspections, and retroactive audits, even for short-term travel like meetings or conferences. Compliance is no longer just good practice, it's a visible and enforced requirement.

So what is an A1 certificate?

An A1 certificate is a mandatory legal document for employees working temporarily abroad within the EU/EEA or Switzerland. It proves that their social security contributions remain in their home country, avoiding dual payments and protecting both employer and employee from unexpected liabilities.

For travel outside the EU to countries with bilateral agreements, a Certificate of Coverage (CoC) serves a similar purpose.

Who issues A1 Certificates?

The certificate is issued by authorities in the country where the employee is insured and employed. For example:

Germany: Statutory health insurers or Deutsche Rentenversicherung

■ France: URSSAF

United Kingdom: HM Revenue & Customs (HMRC)

Why is the A1 certificate important?

This document mitigates cross-border social security risks by proving that the employee remains covered under their home country's system.

Without it, two key risks emerge when working abroad temporarily:

- The employee could lose coverage in their home country
- The employee may be forced into the host country's social security system

Either scenario can lead to dual contributions or loss of entitlements. The A1 certificate, or the Certificate of Coverage (COC) in non-EU treaty countries, prevents this.

When do you need an A1 certificate?

A1 certificates are required when employees travel for business or workations within:

- EU countries
- Iceland, Liechtenstein, Norway, Switzerland
- The United Kingdom

They must be requested from the local authorities in the employee's home country.

What happens if you don't apply?

If your employee is stopped without an A1 certificate, it can lead to serious complications:

- Administrative burdens for HR and employees
- Dual social contribution liabilities
- Limited access to home-country social security benefits
