2. General Information on Data Processing

2.1. Scope of Data Processing: We collect and process various types of information through our website and WorkMotion platforms, necessary to provide and enhance our services. The extent of data processing varies based on the functionalities utilized

by you. While you are not obligated to provide personal data; however, failure to do so may restrict your access to certain functionalities..

2.2. Legal Bases for Data Processing:

- i) Contract Performance (Art. 6 para. 1 b) GDPR): Data processing necessary for the execution or preparation of a contract.
- ii) Legitimate Interest (Art. 6 para. 1 f) GDPR): Processing based on our legitimate interests, detailed within this policy, unless overridden by your rights and interests.
- iii) **Consent (Art. 6 para. 1 a) GDPR):** Processing based on your explicit consent, which you may withdraw at any time, affecting only future processing.
- iv) Legal Obligation (Art. 6 para. 1 c) GDPR): Processing necessary to comply with our legal obligations
- **2.3. Data Deletion and Storage Duration:** Personal data is deleted when it is no longer necessary for the purposes for which it was collected or otherwise processed, unless further retention is required for compliance with a legal obligation or for the establishment, exercise, or defense of legal claims.
- **2.4. Data Subject Rights:** You have rights under the GDPR regarding your personal data, including:
 - i) **Right to Information:** Access to your personal data processed by us.
 - ii) Right to Rectification: Correction of incorrect or incomplete data.
 - iii) **Right to Deletion:** Erasure of your data under certain conditions.

2.5. Data Processing Partners: Data processing is partly carried out by processors, particularly for hosting and analyzing the usage of our website and platforms. These

processors are engaged under strict data protection agreements compliant with Art. 28 (3) GDPR.

- **2.6. International Data Transfers:** Data transfers to third countries outside the EEA are carried out under strict compliance with GDPR, using mechanisms such as Standard Contractual Clauses to ensure data protection.
- 3. Website Usage and Data Processing
- **3.1. Website Functionality:** To display our website and ensure its functionality, we process certain information automatically when you visit www.workmotion.com. This includes essential data needed to maintain the connection and deliver our website content effectively.
- **3.2.** Log Files: Each time you access our website, our server automatically collects specific data sent by your browser. This data is essential for connecting and navigating our site and includes:
 - i) IP address (considered personal data)
 - ii) Date and time of your visit
 - iii) Volume of data transferred
 - iv) Whether the access/request was successful
 - v) Referrer URL (the previously visited page)
 - vi) Browser type and version
 - vii) Operating system use.

This log data is not combined with other personal information about you. We store this data to ensure the functionality of our website and to protect it from attacks. Log

files are deleted after 30 days unless longer retention is required for evidence purposes.

4. Platform

4.1. Employer of Record (EOR) (formerly WorkGlobal) **and Direct Hiring** (formerly WorkDirect)

4.1.1. Personal data of Talents

4.1.1.1. Account Creation and Data Processing: When using our EOR and Direct Hiring services, you as a Talent will be required to create a user account. The creation and use of this account on our platforms necessitate the collection and processing of various types of personal data to facilitate your access to our services and manage

your interactions with us effectively. Depending on the specific services you utilize, we may collect the following data:

- i) Basic Identification Information: Name, date, and place of birth.
- ii) Contact Details: Email address, phone number.
- iii) Content Data: Texts, photographs, videos uploaded during the use of our services.
- iv) Payment Information: Bank account details, payment history to process transactions.

- viii) Sensitive Data: This includes personal data revealing religious or philosophical beliefs, and health data, which are processed under strict compliance with legal protections and consent requirements.
- 4.1.1.2. **Provision of Equipment for Talents:** We offer clients the option to provide their employees (referred to as "Talents" under EOR and Direct Hiring) with necessary work equipment via third-party providers. When utilizing this service:
 - i) Data Sharing with Equipment Providers: The necessary personal data of the Talent (name, address, and telephone number) is shared with third-party providers such as Hofy Ltd, to facilitate the delivery and setup of the equipment.
 - ii) Third-Party Providers: Unless specified otherwise, the equipment is supplied by Hofy Ltd, located at 5 New Street Square, London, EC4A 3TW, UK. To ensure compliance with GDPR and other data protection laws, we enforce strict Data Processing Agreements (DPAs) with each provider. These agreements mandate adherence to stringent security measures and regular compliance audits to safeguard your data.

4.1.2. Personal Data of Client Personnel

4.1.2.1. **Account Creation and Data Processing:** When using our EOR and Direct Hiring services, the Client will be required to create a user account. The creation and use of

this account on our platforms may necessitate the collection and processing of various types of personal data to facilitate your access to our services and manage your interactions with us effectively. Depending on the specific services you utilize, we may collect the following data:

- i) Basic Identification Information: Name, date, and place of birth.
- ii) Contact Details: Email address, phone number.

4.2.1. **Account Creation and Data Processing:** In the Contractor Management model, WorkMotion acts as a platform provider facilitating the engagement between Clients and independent contractors ("Contractors"). Clients use WorkMotion's platform to

create accounts, manage contracts, invoices, and payments directly. The data collected and processed includes:

- Basic Identification and Contact Information: Name, contact details, and other identifiers.
- ii) Contract and Payment Details: Data necessary for contract management and financial transactions, such as bank account information and payment records, etc.
- iii) Usage Data: Information on how services are accessed and utilized, which helps in improving platform functionality.

4.2.2. **Data Collection Purpose and Use:**

- To Facilitate Service Delivery: Data is used to enable Clients to effectively manage their relationships with Contractors, including payment processing and contract management.
- ii) **Compliance and Operations:** Ensuring compliance with legal requirements and smoothing operational processes.

4.2.3. Data Sharing and Responsibilities:

- i) Clients are responsible for the accuracy of the data they provide about themselves and the Contractors they engage. This includes ensuring that they have the right to share this data with WorkMotion for processing.
- ii) As an intermediary, WorkMotion facilitates the connection between Clients and Contractors, as well as between Clients and the licensed payment service provider, Nium. WorkMotion does not engage in the direct provision of payment services but acts to transmit payment instructions from Clients to Nium.
- iii) For U.S.-based Contractor Management engagements, WorkMotion works with an independent third-party compliance provider called CXC to assess the legal classification of such Contractors under applicable U.S. law. WorkMotion

may securely share relevant personal data of the Contractor and the Client with this provider solely for the purpose of performing these assessments.

4.2.4. **Data Security and Retention:**

- Data Security Measures: WorkMotion employs robust security measures to protect data against unauthorized access, alteration, and loss.
- ii) **Data Retention:** Data is retained as long as necessary to fulfill the purposes outlined, in compliance with legal and regulatory requirements.
- 4.2.5. **Rights of Data Subjects:** Contractors and Clients, as data subjects, have rights under data protection laws, including the right to access, rectify, or erase their personal data, restrict processing, and object to processing in certain circumstances. Requests to exercise these rights can be made directly through the platform or by contacting our Data Protection Officer.

5. Cookies

We use cookies on our website and platform for various purposes. A cookie is a small text file containing information that is transmitted by your browser and stored on your computer. These cookies do not contain any personal data. You can also control the use of cookies in your browser and delete cookies yourself at any time. If the cookies listed below have their own option for deleting or blocking them, this is shown in the respective description. Cookies may be necessary to establish a connection or to improve the use of the website.
